The management of the Jennerstown Speedway Complex would like to take a moment to update you on the current season as we are dealing with the effects of the Covid-19 pandemic. The Speedway is now open to private track rentals. Saturday May 16th will be a tire and fuel sale at the speedway for all competitors from 9am-2pm. Strict social distancing will be enforced and all participants are required to wear a mask. Saturday's May 23rd and May 30th will be practice days. Teams must pre-register for practice as a limited amount of spots are available each day. (please see response plan for details) The grandstands will be closed to spectators for both practice days. The speedway is excited to announce that opening night 2020 will take place Saturday June 6th 2020 with a 5 division racing program. A full detailed schedule for the 2020 season will be updated soon.

# Phase 1:



## Covid 19 Track Rental Procedures

The speedway will be operating as a private campground and will be available for track rentals beginning on Saturday May 9th 2020 by **appointment only**. Limited spots are available for each time slot to ensure that CDC guidelines are being followed. Track rentals will be closed to all spectators and teams are asked to have a limited number of crew members present during testing.

### *This in not an open practice*

- Anyone wishing to schedule a test must do so by contacting Mike Belardi at 814-483-6127 to schedule a testing time slot
- Each team must declare the number of crew members who will be attending the track rental. **4 cars max - driver plus 5 crew max** per time slot
  - All attendees must follow CDC guidelines- mask required
- Once all attendees arrive for their scheduled test session the gates will be locked and no one will be permitted in or out until the completion of the scheduled time slot.
  - Teams must park one pit stall apart from any other team - 12'
- Saturday rental session will begin at 10am, Sundays begin at 12:30pm
  - Testing windows will be between 2-4 hours
- Please review the speedway's Covid 19 response plan

# Phase 2:



## **Covid 19 Practice Days**

The speedway will be operating as a private campground and will be hosting practice days once the stay at home order is lifted. Strict regulations and guidelines will be in place in accordance with the CDC guidelines.

- **No spectators will be permitted on the property.**
- **Participants will be limited to 50% the pits capacity**
  - Drivers must register to attend.  
All registration must be done with Billy Hribar- 412-601-0425
- Each team must declare the number of crew members who will be attending  
**Limited to driver plus 5 crew max**
- Entrants will have a specified time to arrive after which all gates will be locked, and no non-essential personnel will be permitted into the facility.
  - All attendees must follow CDC guidelines- mask required
  - Teams must park one pit stall apart from any other team- 12'
- Temple temperatures will be taken before being permitted to enter the speedway.  
No one with a temperature of 100.4 or higher will be permitted to enter.
  - No food or drinks will be sold
- There will not be any personal vehicles allowed in the pits except for those with handicap and medical permits.

## **Business Public Health Resumption Plan for Jennerstown Speedway Complex**

**Statement of Purpose:** To resume limited operations of an outdoor recreation activity, circle track racing, conducted with full regard to public safety guidelines regarding social distancing and proper health measures to limit or eliminate exposure to possible respiratory illness. This will be aided by the facility limiting numbers of employees and attendees, testing Individuals at entry for elevated temperatures, limiting food and merchandise sales, limiting/eliminating gathering areas and providing or requiring Personal Protection Gear (PPG) to employees and participants. w/lt Circle Track Racing, in its manner of conduct, it is possible to largely limit the interaction between participants and employees, as the vast majority of participants maintain and drive their vehicles with very limited outside help. The following steps will be taken during the current medical situation in the State of Pennsylvania.

### **I. Employee Health and Safety:**

A. Prior to opening all employees will receive a safety briefing on the proper conduct of personal safety measures, including the use of Personal Protection Equipment (PPE), and Social Distancing policy for each functional area of the facility for both themselves and for participants. Safety briefing will be done separately for concessions, back gate, and front gate staff.

B. Personal Protection Equipment (PPE) will be issued to all employees based on their work location and function. At a minimum the PPE will be at least a face mask and protective gloves for all employees, to be worn at all times. All employees will have ready access to hand sanitizer at or near their location. Additional spare PPE will be available to replace any PPG that may become compromised throughout the work day.

C. Upon reporting to work all employees will have their forehead temperature taken. The test will be repeated and recorded. Any employee demonstrating an elevated temperature will be sent home and not permitted to return to work without a Doctor's note.

D. The working staff at the facility will be the bare minimum necessary to safely conduct the limited operations of the facility. This will be at least a 30% reduction in staffing.

E. The Emergency Medical Technicians (EMT's) and Fire & Rescue will have the appropriate PPE as is now best practice in the medical area.

## **II. Participant Safety:**

A. Participants will receive a printed handout upon entry detailing social distancing and facility rules regarding safe practices. These include avoiding groups, wearing a face covering/mask at all times, use of hand sanitizer stations, etc.

B. All participants before entry will have a forehead scan. Those with an elevated temperature will not be permitted entry.

C. Except when in or on a race vehicle, where a helmet is worn, all participants will be required to wear a face covering/ mask while on the property.

D. Race car parking in the pits will be spaced out to every other pit stall approx. 12'

E. To assist in keeping social distancing guidelines, participant admissions will be limited to the driver plus 5 crew members - max 6 people per car.

## **III. Spectator Safety:**

A. All Spectators will receive a printed handout upon entry detailing social distancing and facility rules regarding safe practices. These include avoiding groups, wearing a face covering/ mask at all times, use of hand sanitizer stations, etc.

B. All spectators before entry will receive a forehead scan. Those with an elevated temperature will not be permitted entry.

C. All spectators will be required to wear a face covering/ mask while on the property while the governors order remains in place.

D. Signs will be displayed at entry gates and around the facility regarding proper safe health practices and use of face coverings/masks required.

E. To assist in keeping social distancing guidelines, spectator admissions will be limited to a 40% percentage capacity.

#### **IV. General Measures:**

A. Food services will initially be limited and serving lines marked with social distancing guidelines. Based on current health standards in place as the season progresses, more food services may open, but with limits on lines and social distancing enforced. All normal seating areas will be removed or blocked off.

B. Permanent restrooms and porta johns will be operated in accordance with community health standards. Individual Porta johns will be spaced out through the facility, sufficient in number for the capacity expected. Each Porta John will be sanitized on a regular basis.

C. Souvenir stands will be operated in accordance with applicable community health standards.

D. The common areas of the facility will receive regular cleaning with a commercial grade disinfectant solution either by spray or wiping.

E. All point of sale terminals (POS) such as cash registers and their attendant staff will have a physical barrier, typically a piece of clear plastic sheet, to provide an additional shield between actual face to face transmissions.

## **Best Practices Guidelines**

1. Hand sanitizers at critical areas; entrances, concessions/novelties, restrooms, driver registration areas, also plexiglass shielding where applicable.
2. Marking bleacher areas for social distancing as well as pit/parking areas.
3. Marking concession and restroom areas for social distancing.
4. Vendors must have sanitizers at their work areas and maintain distancing.
5. Track security to oversee social distancing practices.
6. No additional activities on race night other than actual racing; i.e. no kids activities, no VIP/promotional activities, no autograph session, no large opening ceremonies.
7. Strict enforcement of only safety crews permitted at the accident scene; no track crews, family members (penalties enforced if not adhered to).
8. Recommend credit/debit sales at concession areas to avoid the handling of cash.
9. Victory lane limited to on track only with driver only and photographs.
10. Temple temperatures will be taken before anyone is permitted to enter the speedway. No one with a temperature of 100.4 or higher will be permitted to enter.
